Objectives and Investment Policy

Objective This Sub-Fund aims to generate long-term capital growth through a concentrated portfolio of equities, equity-related securities, bonds, and currencies. The Sub-Fund will invest primarily in securities of companies, which are incorporated, listed in or have their area of primary activity in Japan.

SFDR Classification: The Sub-Fund qualifies as an Article 8 fund.

Investment Policy In choosing investments, the investment manager looks for shares that are undervalued and that appear to have the potential to rise in price over the long term.

The Sub-Fund may also invest in depository receipts including ADRs and GDRs, convertible bonds, preference shares, warrants and fixed income securities issued by Japan entities.

The Sub-Fund may use derivatives for efficient portfolio management or to manage risks.

Benchmark This Sub-Fund aims to outperform the return of MSCI Japan Index ("Benchmark"). The Sub-Fund is actively managed.

Currency GBP

Recommendation This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

You can place orders to buy or sell shares at any time. Orders placed before 2 PM (Luxembourg time) and on any day that is a banking day in Luxembourg and in the country or countries where the majority of the Sub-Fund's assets are invested will generally be processed that day.

Share Class Policy The shares in mention are accumulation shares (shares that do not distribute dividends).


